Despite a relatively low equity exposure, the first six months were characterised by weak equity markets as a result of challenging economic, market, and geopolitical conditions. However, the second six months saw a pronounced turnaround, with strong returns across both equities and fixed interest as a result of lower interest rate expectations.
